# **Child Safe Standards**

# **Rationale:**

- The Languages policy, sets student learning goals and curriculum development goals in place for the next three years.
- Learning another language has significant educational and social advantages.
- Apart from being directly relevant to the development of communication skills and literacy, it promotes cognitive growth and divergent thinking.
- There are individual benefits to be gained from exploring a wider social and intellectual environment and encountering different ways of looking at the world.

# Aims:

The Language Faculty has a commitment to the following general and specific goals.

#### General

- 1. To support and implement DET initiatives, especially in the areas of:
  - > The Victorian F-10 Curriculum
  - Assessment and Reporting
  - The VCE, VCAL and VET
  - Information and Learning Technologies
- 2. To support and incorporate school based initiatives, especially College Strategic Plan Goals and Priorities with specific focus on:
  - Literacy and Numeracy
  - Student Engagement and Learning
  - > Improve VCE outcomes

# **Specific**

- 3 The Language policy covers the following studies within the Language Faculty at Lilydale Heights College:
  - Japanese
- 4. To develop students' understanding and tolerance of and engagement with other cultures.
- To provide students with access to the power of communication in a multicultural society and a multicultural world.

- 6. To offer students the opportunity to participate in overseas programs and sister school programs.
- 7. To encourage excellence in student work.

# **Implementation:**

- 1. The Victorian F\_10 Curriculum and VCAA documentation is the basis for the documented LANGUAGE Curriculum in the College. The Faculty Leader will be responsible for ensuring the LANGUAGE curriculum is documented, and delivered within the Victorian F-10 Curriculum guidelines, incorporating Literacy and Numeracy.
  - Assessment and reporting procedures and formats for learning outcomes within the Victorian F-10 Curriculum and VCE/ VET, 11 -12, will be reviewed periodically.
  - VCE units in the LANGUAGE Faculty area will be supported and encouraged by the College.
  - Learning Technologies will be progressively incorporated into teaching and learning in the LANGUAGE Faculty Area.
- 2. The LANGUAGE curriculum will incorporate a focus on literacy and numeracy and actively work toward College goals in engagement, attendance and retention.
- 3. Studies in a LANGUAGE subject will be compulsory for Years 7 and 8. Elective units will be offered from Years 9 to 12, years 9 and 10 being incorporated in the vertical curriculum.
- 4. Students will experience cultural activities related to LANGUAGE encouraging awareness and understanding.
- 5. Assessment tasks and work requirements will be consistent across each LANGUAGE unit and will reflect and assess the skills developed in listening, speaking, reading and writing.
- 6. In-country cultural and language tours will be organised by LANGUAGE faculty and other interested parties, in consultation with the College Council
- 7. Different learning styles of students will be catered for within the LANGUAGE chosen, through differentiation including enrichment, extension and acceleration programs. The LANGUAGE faculty will consistently support and encourage the highest possible individual student outcomes.
